

## B of A Loans

Since April of 1967 Memorex employees have been able to obtain special interest rates on personal, home improvement, and car loans from Bank of America, El Camino-Kiely Branch. A preferred interest rate on personal loans will be given to Memorex employees only at the above mentioned branch. The interest rate on car loans varies, depending on the car's age and value.

Applications for these loans are available in your Personnel Office. There is a \$100 minimum on all types of loans; and there is a minimum loan charge of \$15.

You can also start a savings account at the same branch, making your deposits through payroll deductions.

## Training Courses

Manpower Development reports that three new courses, open to all Santa Clara area employees, will begin in February. They are:

**Speed Reading**, a course designed for those who want to strengthen their skills in reading, comprehension, speed and retention. Classes are from 5 to 7 p.m., on successive Thursdays. The first class is February 5.

**Spelling and Vocabulary 1AB**, for those interested in improving their spelling ability and building a larger vocabulary.

Discussions will include history and meanings of word roots, prefixes, suffixes, synonyms, antonyms, and homonyms. The class will last for nine weeks, from 5:30 to 8:30 p.m. It begins February 2.

**Shorthand 1A**, an introductory course in basic shorthand theory, using the Gregg Diamond Jubilee Edition Text Kit. Class lasts 18 weeks, beginning Thursday, February 5. Class time is from 7 to 10 p.m.

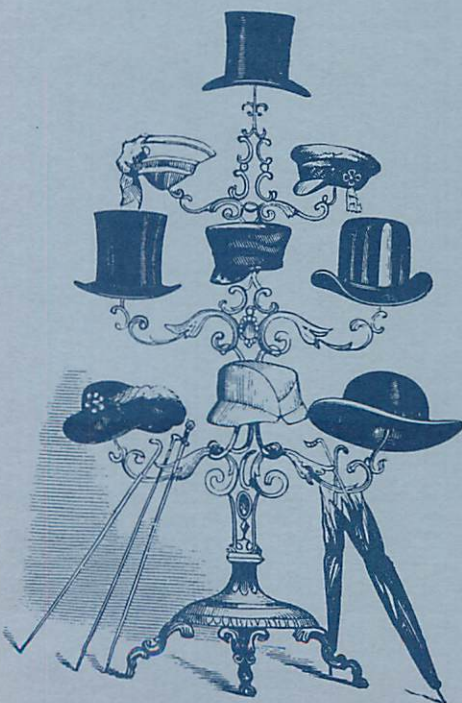
